**Sub :- Request for Conducting Circle Conference of SEWA BSNL for Andhra Pradesh and Telangana Telecom Circles -Reg**

Please refer to the letters cited above of the erstwhile Liaison Officer(SCT) of AP circle regarding installation of Circle Body of AP SEWA BSNL and letter dated 18.03.2016 of CLO (SCT) Corporate Office. Despite several representations from the CHQ Governing Body, Liaison Officer of AP Circle has not arranged to conduct the Circle conference /CHQ Governing Body requests and election process to install the Circle Body.

During the elections conducted on 09.05.2014, the President contestant Sri R Maheshwar Rao has approached the Honourable High Court of AP and High Court has directed the AP Circle administration to conduct the elections within 2 months. Despite honouring the directions of the High Court, administration has filed a counter stating that the matter is within the purview of SEWA CHQ Governing body. Further, the then Ad-hoc CHQ Governing Body has made several requests to CGMT A.P Circle and CLO of BSNL Corporate Office to install Ad-hoc Circle Body to conduct elections.

Surprisingly the Circle Administration has written a letter dated 24.05.2016 to Shri B Babu, Ex Circle President and Shri B Hanumanth rao Ex Circle Secretary to co-ordinate with the groups. Shri R. Maheshwar Rao was not at all taken in to consideration to have a dialogue on the dispute. Therefore contested panel of Shri R. Maheshwar Rao has not attended the proposed meeting for which the meeting was postponed by LO of AP Circle. Despite of instructions from the CLO of Corporate office vide letter dated 18.03.2016, AP Circle administration has kept making proposals to have a meeting with self-created groups.

Similarly, the LO (SCT) of AP circle has issued one more letter dated 28.06.2016 (copy enclosed) to attend the meeting at 11:00 AM of 29.06.2016. As the addressees are residing at distant places and away from Hyderabad, they were unable to attend the meeting. Meanwhile the Dy. GS of CHQ, working in AP Circle consulted with GS and NP of CHQ body and taken the initiation to conduct a meeting with all DPs & DSs of all 23 SSAs in AP & Telangana states to pass a resolution for conducting the elections smoothly in two circles separately.

***On 05.07.2016 at Vijayawada of AP Circle, a seminar on Reservation Policy & Circle working committee meeting was conducted for which National President Shri P N Perumal, General Secretary Shri N D Ram and Deputy General Secretary Shri B.Hanumantha Rao have attended. All the District Presidents and District Secretaries of 23 SSAs of combined AP Circle have attended the meeting and a resolution was passed that Ad hoc Committees for both the Telangana and Andhra Pradesh Circles are to be installed on recommendations of CHQ Governing Body which will conduct election process smoothly. A copy of the resolution is enclosed herewith for your information please.***


Administration of erstwhile AP Circle has become a puppet in the hands of some Trade Unions and kept writing to Corporate Office that factions are running high and harmony between the two groups is to be maintained for conducting election process. It is much painful to reiterate that the administration is not in a position to trust the bye-laws of SEWA BSNL and played delay tactics for the non-existence of AP Circle Body. Instead of initiating the process for elections as per bye laws, administration kept writing to the self-created groups to have a dialogue on elections which is very hilarious. Still the administration of erstwhile AP is not in a position to honour the recommendations of the CHQ Governing Body to establish Ad hoc Body to conduct the elections smoothly.

Further, it is requested to instruct both the Telangana and Andhra Pradesh Circle administrations to approve the Circle Ad-hoc body nominated by CHQ body to conduct the elections for AP & Telangana Circles, as per the guidelines issued by CLO. As the full pledged CHQ Governing Body is in force, the election process of the both circles will be conducted by the Ad hoc committees proposed by the CHQ Governing Body and also under the observation of SEWA CHQ New Delhi in a smooth way.
