Sub :- Request for elimination of disparity in eligibility criteria for LICE in r/o Junior Telecom Officers –under 50% Quota to be held on 22.05.2016 – reg.

It may kindly be permitted to submit few lines for your kind consideration which enables justice to the SC/ST employees who intend to appear for LICE examination under JTO 50% quota to be held on 22.05.2016.

Several SC/ST candidates were recruited as TTAs during 2007 under direct recruitment notification No TA/RE/22-9/07/25 dated 06.11.2007 and further on selection, candidates were sent to undergo training batch wise.

As per the conditions of the 50% quota for LICE-JTO examination, candidates who were permitted for TTA training during 02.06.2008 to 08.08.2008 and 16.08.2008 to 22.08.2008 were made eligible for appearing the above said examination and the candidates who underwent TTA training after 30.06.2008 were restrained for applying the above said examination.

It is requested to permit the candidates to forward their applications for the above said examination who underwent TTA training after 03.06.2008 as they were selected under same notification and further the CAT-Hyderabad has also directed to permit the same vide OA No 021/00357/2016 dated 07.04.2016.

Regarding the eligible condition in r/o NE-9(SCALE), 5 years condition may also be withdrawn as the qualified candidates with Diploma and Graduation are underprivileged for writing the said examination

This guidelines will be applicable to all candidates this exam will be conducted on 22.05.2016 for applying last date is 14.04.2016.

In this connection we may state that the relaxation and concessions should be provided to SC/ST candidates admissible as per constitution of India, DOPT orders


In view of above we humble request your good office to take initiative and issue corrigendum of the above subject of the following lines.

2. The educational qualification for SC/ST in JTO LICE exam may be declared any degree as mentioned for JAO examination


We hope that the BSNL CO will issue necessary corrigendum as prayed above in accordance with the constitution and Institutional safeguard the SC/ST candidates

**Subject:- Holding of Limited Departmental Competitive Examination
(LICE) for promotion to the post of Junior Telecom Officer
(Telecom) (JTO (T)) in BSNL - Clarification reg.**

As per the Interim Orders given by various CAT Benches, with the approval of the Competent Authority in BSNL, it has been decided to **provisionally allow** all those TTAs to appear in the Limited Internal Competitive Examination (LICE) for promotion to the post of Junior Telecom Officer (Telecom) (JTO (T)) to be held on 22/05/2016, for whom examination for Direct Recruitment in the TTA grade was held in the year 2007 and training was completed after 01/07/2008. However, the eligibility of these provisionally allowed candidates would be subject to the outcome of these Court cases/final approval of the Competent Authority in BSNL.

Accordingly, it has been decided to **allow only those candidates, who have been provisionally allowed, as per the aforesaid clarification, to appear in the aforesaid LICE, to register Online between 15/04/2016 and 22/04/2016 midnight.**



Subject: Allowing all the TTA's of 2007 batch to appear in the LICE for promotion to the post of JTO Scheduled to be held on 22.05.2016.-reg.

I am directed to refer to various court cases which have been filed by the TTA's of 2007 batch who completed their training after 1st July 2008 for allowing them to appear in LICE for promotion to the post of JTO as their batch mates who completed their training before 1st July 2008 are eligible to appear in LICE as they have completed 5 years of service as per requirement of Recruitment Rules 2014 as on 1st July,2013.

In one such case where applicants had approached Hon'ble CAT,Hyderabad bench for allowing them to appear in LICE proposed to be held on 22.05.2016 as they belong to the same batch. CAT,Hyderabad has ordered that:

" In the meantime by considering the submissions made by the Learned counsel for the Applicants by way of an interim measure, Respondents are directed to permit the applicants to write the JTOs Limited internal competitive examination scheduled for 22.05.2016 or any other subsequent date pursuant to the notification dated 4.03.2016 issued by the 5th respondent, subject to the condition that they have been selected and recruited as Telecom Technical Assistant by direct recruitment on the basis of the results of the competitive examination held on 29/30.12.2007 in AP circle. Respondents are further directed to allow the applicants to submit their application for the above said examination manually within two weeks from today."

In view of the above, I am directed to convey the approval of competent authority to provisionally allow all those TTAs to appear in LICE for promotion to the post of JTO scheduled to be held on 22.05.2016 for whom exam for Direct recruitment in the TTA grade was held in the year 2007 and training was completed after 1.07.2008.

However this will be subject to final approval of the competent authority.
